SECTION 16 REPORTING OBLIGATIONS

The undersigned hereby makes, constitutes and appoints Randall M. Chesler, Ron J. Copher, Martha Tannehill, and Sheli Babb, signing singly, as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:

(1) prepare, execute, acknowledge, deliver, and file, with respect to the securities of Glacier Bancorp, Inc., a Montana corporation (the "Company"), for and on behalf of the undersigned, Forms 3, 4, and 5 (including any amendments thereto) with the United States Securities and Exchange Commission ("SEC") and any securities exchange(s) or similar authority as considered necessary or advisable in accordance with Section 16(a) of the Securities Exchange Act of 1934 and the rules and regulations promulgated thereunder, as amended from time to time (the "Exchange Act"), and any other forms or reports the undersigned may be required to file in connection with the undersigned's ownership, acquisition, or disposition of securities of the Company, including forms required to generate codes for the SEC's electronic filing system; and
